The Contest is designed to engage youth and others in the community in a fun event that will draw attention to education and career options related to Science, Technology, Engineering and Math (STEM).

The 9th Annual Sunshine Coast Popsicle Stick Bridge Building Contest will be held on May 26, 2019.

Students from elementary and high schools are encouraged to get involved. We have arranged with some teachers to work with their students in the classroom to design and build bridges... and get extra school credits for their active participation... now how cool is that!

Entrants will receive a standard kit of building materials from which they will construct their bridge. The kits are now available for a small deposit of \$5 from GBS in Sechelt and Gibsons. The \$5 is refunded for those who bring their bridges for testing on May 26, 2019. Those who wish to participate in testing their bridge will formally register for the competition and the bridges will be tested to failure.

In 2019 we will distribute over 200 kits and expect to have about 75 entries for testing.

And yes, adults are also invited to build a bridge and compete for prizes.

Speaking about prizes, we will offer over \$1500 in cash prizes and special awards. Overall we are working to offset all direct costs.

All event organization is being carried out by local volunteers.

Registrants will receive a juice box and cookie (all donated), and those who pre-register will receive a slice of pizza. During the event we will show videos of bridges from around the world, including some bridge failures... all in keeping with what we will be doing with all popsicle stick bridges entered.

We appreciate all sponsors and will be certain to acknowledge this generous support by referencing all sponsors on posters, at the event and in post-event notifications.

The Popsicle Bridge Contest is being offered as a community event under the umbrella of Technology Festival, a new enterprise set up on the Coast to offer various initiatives to promote Science, Technology, Engineering and Math (STEM). The Popsicle Bridge Contest is being organized by dedicated volunteers in our community including Lisa Murata who has been helping with the Bridge Contest for years and is the Chair and prime organizer for the 2019 event. Roger Sayer, a retired Professional Engineer (Non-practicing), has been extraordinarily helpful in serving as the Popsicle Bridge Contest contact with Engineers and Geoscientists BC and in raising sponsorships for this event. John Leech, the recently retired CEO of the Applied Science Technologists and Technicians of B.C., a professional regulatory body of over 10,000 in B.C., is involved in raising sponsorships for the Contest and in framing the Technology Festival initIative.

Technology Festival (TechFEST) has established a bank account with the Sunshine Coast Credit Union in Gibsons (with at least two signatures for expenditures) and is currently in the process of registering as a not-for-profit Society under the B.C. Society Act.

Subject: CAYCUSE RECREATION SITE, NEW TOURISM HUB FOR NITINAHT LAKE

COURTENAY – Nitinaht Lake, a world-renowned destination for windsurfers and kiteboarders, will soon be home to new visitor recreation amenities. Developed by the Ditidaht First Nation, the Caycuse Recreation Site project will receive \$237,000 in funding support from the Island Coastal Economic Trust.

"Windsurfers and kiteboarders, as well as West Coast Trail hiking enthusiasts, have historically been our target markets at Nitinaht Lake," explained Ditidaht Development Corporation CEO Bryan Cofsky. "These new visitor amenities will serve to draw broader and more family-based markets into the area, supporting the development of new businesses, services and sustainable employment opportunities for our rural community members."

The Caycuse Recreation Site project will feature the development of new facilities which include 52 new campsites and related cultural tourism elements. The project will also include the development of 5.1 km hiking trail

access to the Looper Creek Canyon, a unique cave system characterized by limestone karsts and watery narrows that has potential to gain regional and provincial recognition.

"We have long-term aspirations for this area, defined in our "Unleashing the Nitinaht" plan, a tourism initiative to transform Nitinaht into a world-class tourism destination," said Ditidaht First Nation Chief Robert Joseph. "The project will enable us to build on our existing expertise in cultural recreation and trail management, and serve as a stepping stone to attract new visitor markets while continuing to build our vision where we are leaders of change, not recipients."

The project, with a total budget of more than \$1.2M, has also been designed to integrate employment and skill training opportunities for the community.

"In the past few years we have seen a growing trend in the development of remote Indigenous tourism hubs in several parts of the Island and Coastal region," said ICET Chair Josie Osborne. "Visitors are seeking authentic experiences and are interested to learn directly from Indigenous communities and tourism operators about their territories and culture. The Ditidaht First Nation is creating opportunities to do just that."

An economic analysis of the project demonstrates that 3-5 years post-completion, the additional campsites, trails, and related activity will generate an additional \$775,000 of tourism spending per year, leading to 4.9 permanent new jobs. During the 6-month construction phase, 14 temporary full-time equivalent jobs will be created.

Construction is now underway with completion anticipated by the end of November.

#### **About the Island Coastal Economic Trust**

Created and capitalized by the Province of BC, the Island Coastal Economic Trust (ICET) has been at the forefront of economic diversification, planning and regional revitalization for the past twelve years.

ICET is independently governed by a Board of Directors and two Regional Advisory Committees which include more than 50 locally elected officials, MLAs and appointees from the Island and Coast. This exceptional team of leaders collaborate to set regional priorities and build vital multi-regional networks.

Through a community centered decision-making process, ICET has approved more than \$50 million in funding for over 200 economic infrastructure and economic development readiness projects. These investments have leveraged over \$270 million in new investment into the region creating more than 2500 construction phase jobs and 2600 long term permanent jobs.


